SCOPE OF WORK

Bid Item: Contractor agrees to provide **LAWN CARE SERVICES** for all properties owned and/or managed by the Estes Park Housing Authority

This bid excludes taxes. All work shall comply with all local, State and Federal Laws including the Environmental Protection Agency (EPA).

The purpose of this Contract shall be to provide lawn care services, including mowing and general landscaping services which includes blowing off and removing debris, trimming, edging, and weed removal per property. Scheduled work shall have a response of five (5) business days. This shall include all labor, equipment, and supplies.

Services to be provided:

Mowing at each property in such a manner to create a neat appearance. Where mowing is not possible a trimmer/weed eater shall be utilized.

Blowing off or removing of clippings on walkways, sidewalks and parking lot.

Trimming around buildings, flower beds, shrubs, fencing, borders, and other structures to provide a neat and uniform transition.

Edging and Weed Removal around, on, within, and at walkways, driveways, parking areas and concrete pads. Maintenance staff will direct contractor regarding each property’s specific needs.

Price per mowing event, which includes blowing off debris, trimming, edging and weed removal.

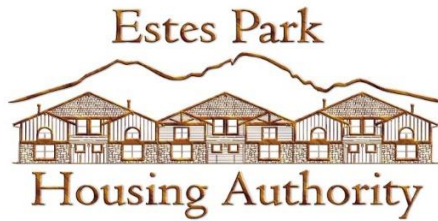
