## **SCOPE OF WORK**

**Bid Item:** Contractor agrees to provide interior painting services (including all labor, equipment and materials excluding paint) for properties owned and/or managed by the Estes Park Housing Authority

Contractor shall be responsible for keeping window coverings clean and paint free, protect all doors, trim, light fixtures, floor coverings and filling of all nail holes. Contractor shall make all minor drywall, door, trim, etc. repairs and/or patching prior to painting. Any major drywall repair or other repairs shall be negotiated with Owner prior to applying paint. Acoustical ceilings shall be sprayed. All light fixtures shall be left in place and masked for protection. Contractor shall leave apartment clean and free of any materials used and/or paint spills, overspray, etc.

Scheduled work shall have a response requirement of 5 business day and emergency work shall have a response time of 2 hours.

Bid excludes sales taxes.
